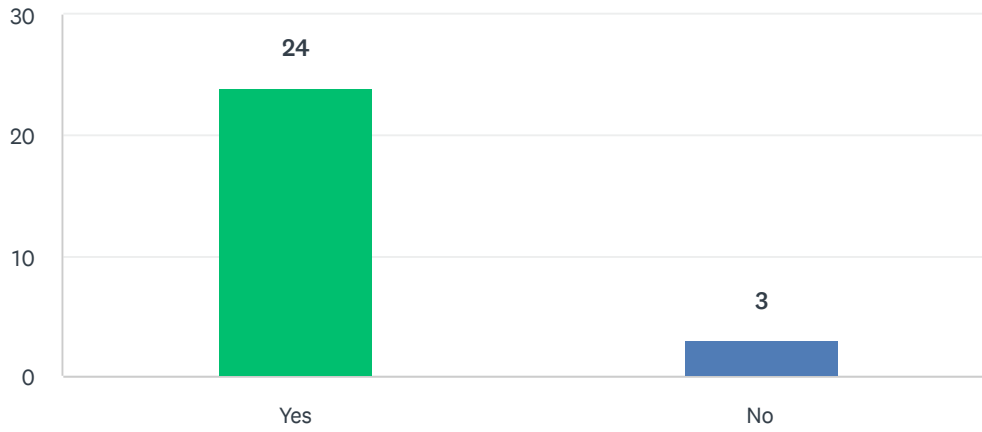


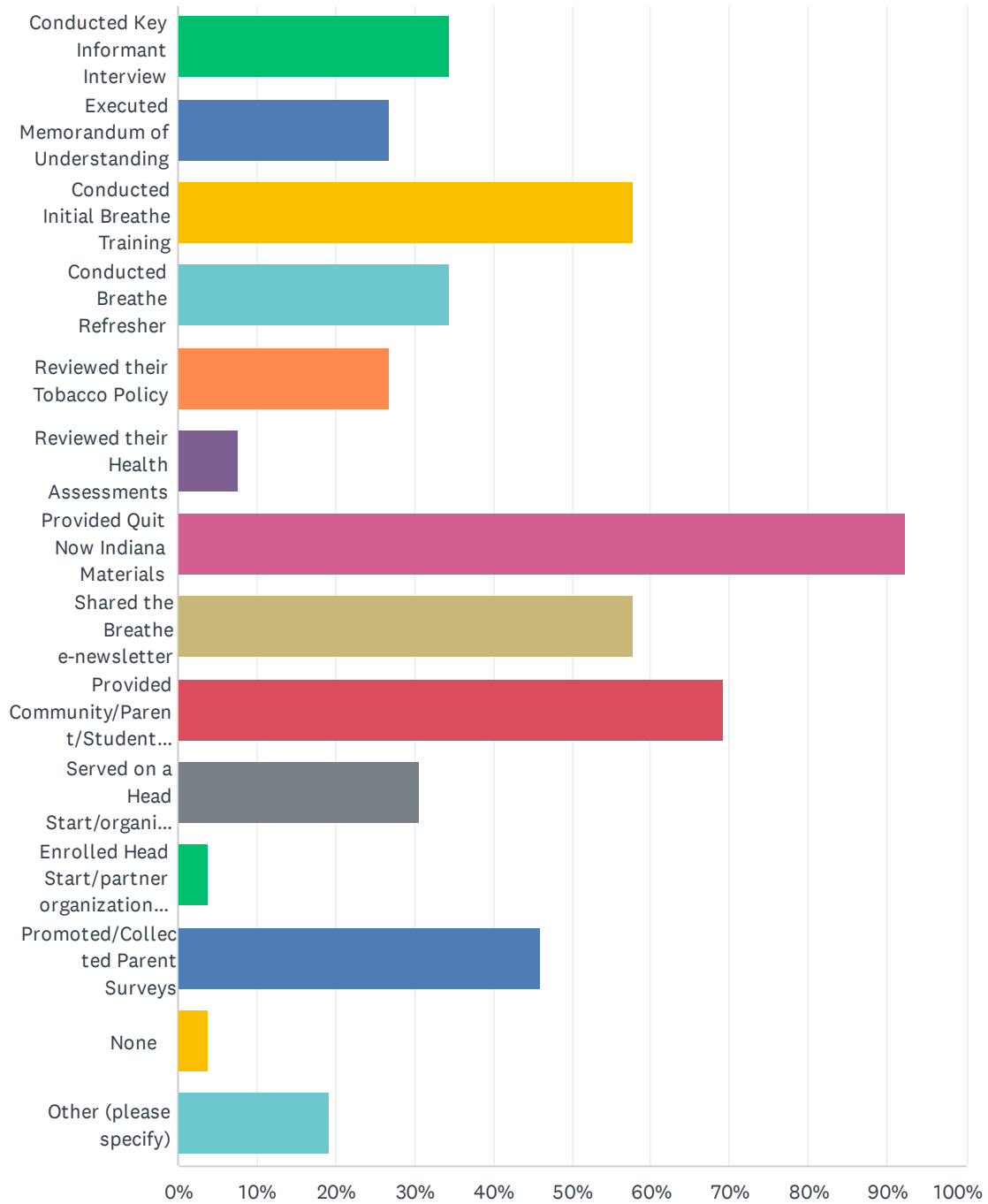
Q2 Does your current workplan include the Tobacco Free Families/Breathe indicator (Grant Year 1: July 1, 2023- June 30, 2024)?

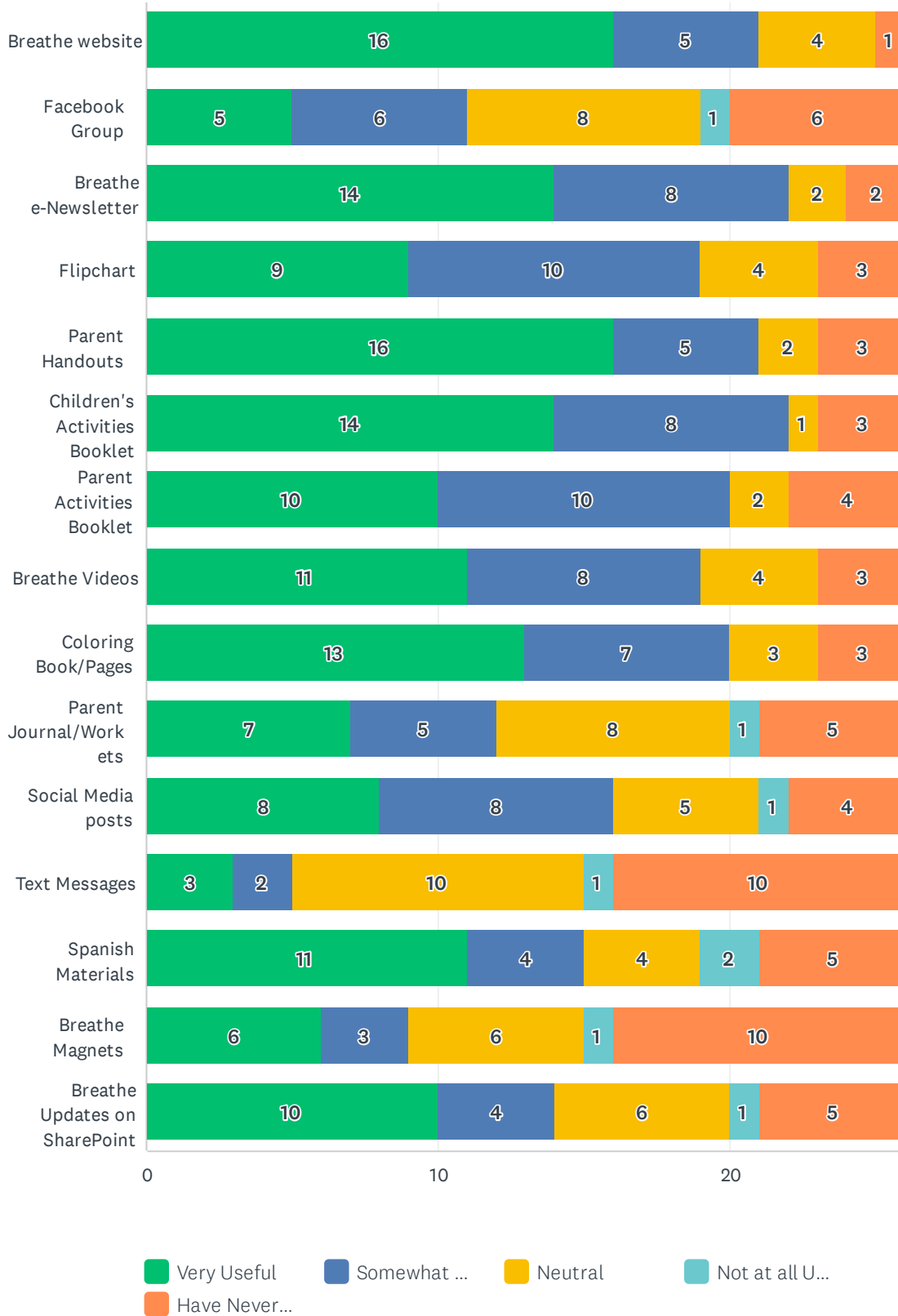

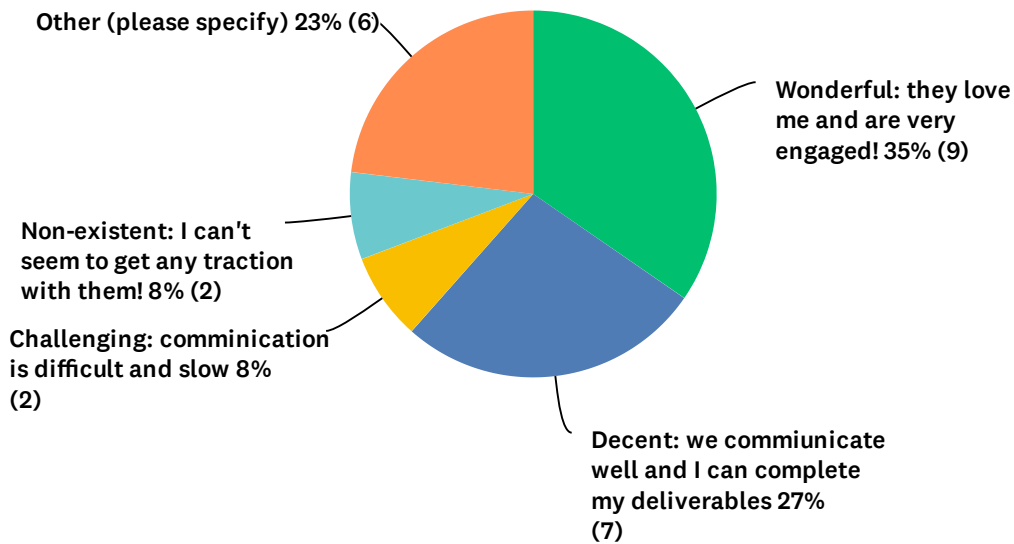

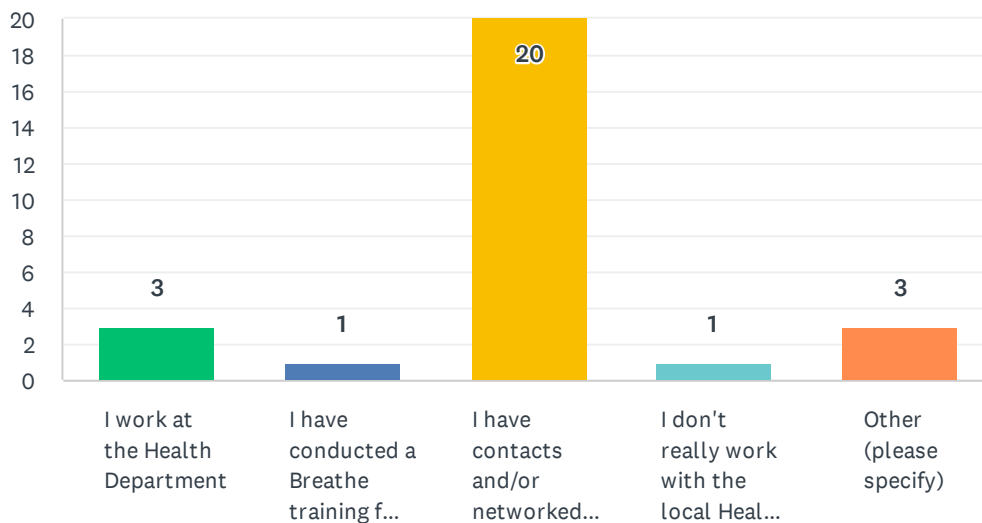

We had a contest for the parents and gave away Bath and Body Works baskets to those who turned in their parent activity. The parents really liked this and seemed to try hard to do them. If they turned in the child activity too, they got bonus points for the contest. The teachers even participated in monthly contest because they were keeping the data. It was such a hit that every lesson had been sent home by Christmas for the parents to do. The teachers sent home one lesson a week. This coming year we are doing one a month. One a week may have been overwhelming for the parents and that's why it seemed hard for them. I go into the class once a month to read to the students and I tie it into what I am sending home to the parents for that month, and I've done some activities out of the children's book with them. I had an opportunity to talk to the parents at the Thanksgiving meeting and had a great turnout. They had to come to the meeting to get the turkey dinners. Lastly, I was the guest speaker at the graduation day that all the kids participated in. There were over a 100 people there and I recapped the year and again promoted Breathe for the next year and the Quit Now resource.
